

TREA Online Privacy Policy

Protecting your private information is our priority. This Statement of Privacy applies to The Rock Enrichment Academy and therockenrichmentacademy.org and governs data collection and usage. For the purposes of this Privacy Policy, unless otherwise noted, all references to The Rock Enrichment Academy include therockenrichmentacademy.org, TREA, The Rock Education Alliance and therockeducationalliance.org.

The TREA website is an educational site. By using the TREA website, you consent to the data practices described in this statement: Collection of your Personal Information.

In order to better provide you with products and services offered on our Site, TREA may collect personally identifiable information, such as your: - First and Last Name - Mailing Address - E-mail Address - Phone Number - Student name, Grade and campus location/s - Payment details

If you purchase TREA's products and services, we collect billing and credit card information. This information is used to complete the purchase transaction.

We do not collect any personal information about you unless you voluntarily provide it to us. However, you may be required to provide certain personal information to us when you elect to use certain products or services available on the Site. These may include: (a) making a payment on our Site; (b) making a charitable donation on our site; (c) submitting your credit card or other payment information when purchasing products and services on our Site or making a donation. To wit, we will use your information for, but not limited to, communicating with you in relation to services and/or products you have requested from us. We also may gather additional personal or non-personal information in the future.

Use of your Personal Information TREA collects and uses your personal information to operate its website(s) and deliver the services you have requested. TREA may also use your personally identifiable information to inform you of other services available from TREA and its affiliates.

Sharing Information with Third Parties TREA does not sell, rent or lease its customer lists to third parties. TREA may share data with trusted partners to help perform statistical analysis, send an email, provide customer support, or arrange for recurring payments or donations. All such third parties are prohibited from using your personal information except to provide these services to TREA, and they are required to maintain the confidentiality of your information.

TREA may disclose your personal information, without notice, if required to do so by law or in the good faith belief that such action is necessary to: (a) conform to the edicts of the law or comply with legal process served on TREA or the site; (b) protect and defend the rights or property of TREA; and/or (c) act under exigent circumstances to protect the personal safety of users of TREA, or the public.

Automatically Collected Information Information about your computer hardware and software may be automatically collected by TREA and specific to payment collection only. This information can include: your IP address, browser type, domain names, access times and referring website addresses. This information is used for the operation of the service, to maintain quality of the service, and to provide general statistics regarding use of the TREA website.

Right to Deletion Subject to certain exceptions set out below, on receipt of a verifiable request from you, we will:

- Delete your personal information from our records;

and

- Direct any service providers to delete your personal information from their records. Please note that we may not be able to comply with requests to delete your personal information if it is necessary to:

- Complete the transaction for which the personal information was collected, fulfill the terms of the Financial Agreement, or provide a good or service requested by you, or reasonably anticipated within the context of our ongoing business relationship with you, or otherwise perform a contract between you and us;

- Detect security incidents, protect against malicious, deceptive, fraudulent, or illegal activity; or prosecute those responsible for that activity;

- Debug to identify and repair errors that impair existing intended functionality;

- Exercise free speech, ensure the right of another consumer to exercise his or her right of free speech, or exercise another right provided for by law;

- Engage in peer-reviewed scientific, historical, or statistical research in the interest that adheres to all other applicable ethics and privacy laws, when our deletion of the information is likely to render impossible or seriously impair the achievement of such research, provided we have obtained your informed consent;

- Enable solely internal uses that are reasonably aligned with your expectations based on your relationship with us;

- Comply with an existing legal obligation;

or

- Otherwise use your personal information, internally, in a lawful manner that is compatible

with the context in which you provided the information.

Children Under Eighteen

TREA does not knowingly collect personally identifiable information from children under the age of eighteen. If you are under the age of eighteen, you must ask your parent or guardian for permission to use this website.
